- A free specimen copy is to be handed over/sent to the Burgenländisches Landesarchiv unsolicited within four weeks of the publication.
- The reproduction(s) may not be used or distributed for any purpose other than that stated above.
- Written approval from the Burgenländisches Landesarchiv must be obtained for renewed use.
- The provisions also apply to all self-made copies, photographs and/or digital copies of archival material of the Burgenländisches Landesarchiv.
- Insofar as third parties have the right of exploitation and use, the relevant licenses must be obtained by the applicant himself/herself before use. The applicant undertakes to indemnify and hold harmless the Amt der Burgenländischen Landesregierung for any claims against the Amt der Burgenländischen Landesregierung made by the rights owner or the person entitled to use the work as a result of the applicant failing to acquire the rights of exploitation and use.
